Important dates:

- * **December 13th- Application closes at midnight (new extended deadline!)**
- * January 4th- Letters will be mailed with decisions
- * January 15th- Deadline for accepted scholars to declare their intention to attend for the 2021- 2022 school year.

This year's application no longer follows a "first come, first served" format. Our application committee developed a points-based application system to determine acceptance. Additionally, we have added a recommendation piece where scholars can choose their favorite teacher, coach, or mentor to answer 10 multiple choice questions on their behalf.

Ignite's application will continue to focus on scholars who are interested in career exploration within one of our career focused programs. In addition, Ignite's application is geared towards scholars who are looking for a different educational experience. While grades are important, our only academic requirement is that applicants are on target for a grade level appropriate high school English and Math course.

Current scholars do not have to complete this application, but feel free to pass this information along to anyone that might be interested.

From the Superintendent

Dear Boone County Families,

As we enter the final two school weeks of 2020, I want to share a draft of what we are planning for our second semester of the school year. This framework for the winter and spring months is designed so that you may anticipate how we plan to move forward. Of course, any planning that we do may need to be adjusted for the situation at the time.

Unfortunately, it appears that we will have a long and challenging winter with COVID-19 as the case numbers in our community and region are extremely high. Several medical experts have expressed their concerns that COVID-19 numbers and the general healthcare situation across the country may only worsen during the winter months. Therefore, we must emphasize the support and improvement of virtual instruction and mental health activities across the district and also be prepared to transition to in-person instruction when the conditions are appropriate. Navigating through the 2nd semester, we will use our updated decision-making criteria for opening and closing, see below.

Boone County School District COVID-19 District & School Status Decision-Making Criteria

The Boone County School District is working very closely under the guidance of the Centers for Disease Control and Prevention, the Kentucky Department of Education and Northern Kentucky Health Department to develop on-going plans for the 2020-2021 school year. In addition to these government entities, we regularly collaborate and learn from regional healthcare providers to ensure that we balance the needs of our students, which include socioemotional health, school participation, and academic achievement.

As a district, we may have to close a portion of a school, a single school, or multiple schools; however, we will refrain from closing the entire school district if at all possible.

When making decisions about the status of our district and schools, we will consider multiple measures of the safety and health of our students and staff. These important decisions are made in the context of each individual school situation using the following information:

- Health & well-being of students and staff
- Academic and socioemotional performance and needs of students
- Incidence Rate (daily new cases per 100K population, 7-day rolling average)
- Trend line of daily new cases per 100K population
- Infection rate
- Quarantine data and its impact on schools
- Successful implementation of school health & safety protocols
- Directives from the NKY Health Department, KY Department of Education, and KY Governor

Here is the draft general framework and schedule for the 2nd half of the year:

1. **Return after Holiday Break (week of Jan. 4th)** – we will return from the holiday break providing virtual instruction for a period of two weeks, pending COVID-19 metrics in our schools and county. This buffer period is necessary to allow potential cases from holiday gatherings to be identified. This two-week window is a time where we need your help in returning to in-person instruction by the limiting of social gatherings and following the same safety protocols we use in our schools: wearing face masks, practicing social distancing, washing hands often, and cleaning common surfaces.
2. **Begin the return to In-Person instruction using the Hybrid model on Tuesday, January 19th** – after the MLK holiday we will return on Tuesday, pending COVID-19 metrics in our schools and county, using our A/B hybrid schedule to reduce student numbers in the schools after the buffer period. We will use our school & district decision making criteria to open or close during this time. This model would reduce student numbers and provide additional social distancing during the winter period.
3. **Transition to 4-days a week of In-Person Instruction the end of the 3rd quarter on Thursday, March 18th** – Pending COVID-19 metrics in our schools and county and our decision making criteria, this is our target date for the preferred instructional model. However, we may need to move this date as appropriate based on the current conditions.
4. **Return from Spring Break on April 19th using the Hybrid model for one week** – this would reduce student numbers and provide additional social distancing after a potential period of student and/or family travel during the break. After this week, the district would transition back to 4-days of instruction per week pending COVID-19 metrics in our schools and county and our decision-making criteria.
5. **Complete the 2020-2021 School Year** – we will celebrate the accomplishments of our students and staff at the end of the school year, hopefully in-person.

I cannot emphasize enough this is a rough draft of a general framework of the semester. The goal is to communicate a general plan of action to everyone with full knowledge that we will have to make adjustments based on the current situations but that we will limit transitions as much as possible as they are stressful, difficult, and challenging for everyone. As many schools are still working hard to get parents' decision-making completed for the 2nd semester, I ask that you contact your child's school if you wish to change their mode of instruction to in-person instruction or virtual instruction.

Take care of yourself, your family, and your community.

Ignite Amnesty Days

Just a reminder, while our scholars are all learning virtually, We are implementing Ignite Amnesty Days December 7-18. During this time, we will be focusing on connecting with scholars in real time and reinforcing the curriculum that has been taught so far during the 2nd quarter.

Your scholar will be required to log in for synchronous learning Monday, Tuesday, Thursday, and Friday. This is MANDATORY for ALL SCHOLARS. While scholars are logged in, they will turn in and/or re-do 3 assignments per class, per week, minimum. This equates to a minimum of 18 assignments each week and will have a huge impact on your scholars' learning and grades.

Please note that if your scholar does not log in to every course, every period, they will be counted absent for that class, unless released by a teacher. Keep in mind that these absences will add up and can create truancy issues.

Starting Monday, December 14, scholars who log into class, but do not participate, will receive a discipline referral for skipping class. This does not apply to scholars who have been officially released by their teacher.

Scholars and their parents/guardians who are counted truant will be contacted by Ignite administration.

The schedule for logging in to each period for synchronous learning on **Monday, Tuesday, Thursday and Friday** is:

1st Period 8:00-8:50
2nd Period 8:55-9:45
3rd Period 9:50-10:40
Lunch 10:45-11:35
4th Period 11:20-12:10
5th Period 12:15-1:05
6th Period 1:10-2:00

All Calls

You will receive an automated phone call if your scholar has been counted absent for 1 or more periods a day. If you believe the absence was recorded in error, have your scholar contact their teachers. Scholars who are finishing up college classes, or have been released by a teacher from logging into a specific class will not receive a phone call for that class.

Wednesdays

Scholars will be completing CERT testing and meeting with their mentors on Wednesdays. They will continue working on assignments this day on their own.

We sincerely hope this will help all of our scholars, particularly those that are struggling. These are difficult times and have proven to be challenging for even the most responsible scholars. We believe that all our scholars are capable of accomplishing great things, even during the most trying times and we have very high hopes for the next week.

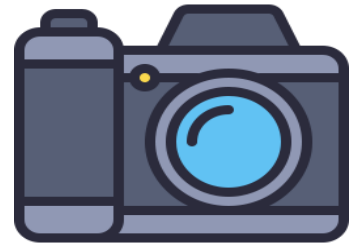
